Ginny Hartman was not looking for a chaplaincy or even looking for a full time position when she moved to the Lancaster area in 2010. She had worked as a chaplain and also as a critical care and public health nurse when she lived in Ohio. She has always felt personally drawn to caring for seniors. In fact she spent 12 years being a caregiver for her parents, developing a real understanding for other caregivers thru her experiences which she describes as "both difficult and rewarding". Following her own path, she travelled for several years from Ohio to Indiana to attend Associated Mennonite Biblical Seminary, adding a degree and an education that has further expanded her ability to understand people.

Here in Lancaster, members of her church learned about the open position of Chaplain here at Pleasant View and encouraged her to apply, sharing the opinion that the position just "seems like you." In March, Ginny's path

led her to accept the offer to become our Chaplain. She finds it "very rewarding to hear the stories of people's lives" and finds it "an honor to walk beside them on their journeys." Her work here includes working with both residents and staff. "It's a gift to be with so many talented people."

Ginny finds that the beauty of our surroundings here at Pleasant View "oozes into the inside, into the hearts of people here." She says that we are blessed with a precious beauty that affects the atmosphere here at Pleasant View. Ginny feels that the women who founded Pleasant View envisioned a place of both peace and rest. She describes Pleasant View as "a place of peace for those who serve and those who live here," and she herself experiences that peace. "Come unto me and I will give you rest." Ginny senses Christ's invitation as she walks the halls and follows her own path at Pleasant View.

RECOGNIZED AS LANCASTER HABITAT RESTORE 2014 PARTNER OF THE YEAR

Over the past year, Pleasant View Retirement Community embarked on extensive renovations to its Residential Living apartments, cottages and common areas to offer upgraded features and added amenities. Pleasant View turned to Lancaster Area Habitat for Humanity to find a home for gently used building materials, fixtures and furniture set to be replaced, but still in good condition. Through their partnership, these items are donated to the Lancaster Area Habitat for Humanity's ReStore, a non-profit business specializing in the resale of new and gently used building materials

and supplies to the public. Habitat ReStore is then able to provide additional funding to support Habitat for Humanity's house-building goals, expand opportunities to serve a broader base of the low-income community by providing low-cost materials, and provide good


Tax Smart Philanthropy

All donors to Pleasant View Retirement Community share an important reward for their generosity: they receive personal satisfaction knowing that they have contributed to the health and well-being of all members of the Pleasant View community. Support is given to the Pleasant View community in numerous ways – through cash or by credit card, by including Pleasant View in estate plans, designating Pleasant View to receive memorial gifts to honor loved ones and by participating in fundraising events. Whether it's support for cognitive care, our building fund or the endowment for benevolent care –gifts from many,

many thoughtful donors contribute to the quality of life and care for each and every person who comes to call Pleasant View home.

Gifts are made when donors believe in our mission – to enhance the quality of life for those we serve in a Christ-like manner. There are many ways to advance the mission. The availability of income tax deductions offers options for a charitable person to be even more charitable. As the end of the calendar year approaches, you may be considering a gift to Pleasant View and the variety of ways to receive tax benefits for giving.

Here are several gift options with added tax benefits to consider...



Gifts of cash or by credit card – Gifts to Pleasant View are tax deductible to the extent of the law. Donors can choose to give through the web site using the secure online site by going to www.pleasantviewrc.org and selecting the green CONTRIBUTE option on the left.

Gift of appreciated stock – If you donate securities that have appreciated in value and held for more than a year, you have an opportunity to avoid the capital gains tax that otherwise would apply if the securities were sold. This tax savings may make this form of giving very appealing. Directions for making gifts of stock are available from the Community Advancement Office.


IRA Charitable Rollover – Individuals can direct all or a portion of their mandatory distribution from retirement funds to go directly to Pleasant View. A more favorable tax outcome may result from this charitable rollover than by simply withdrawing the funds then making a gift.

Bequests – Including Pleasant View in your will can provide a tax saving to your estate in the future. Calendar year end is an excellent time to make sure your estate plans are up to date. The official legal language to use is "I, [name], of [city, state, zip], give, devise and bequeath to Pleasant View Retirement Community [written amount or percentage of the estate or description of property] for its unrestricted use and purpose."

Pleasant View Giving Partnerships provide a way to honor and recognize donors for their integral part in advancing the mission of the community. All requests to remain anonymous are honored.

The Director of Community Advancement can assist in planning support of Pleasant View and help you align your charitable giving with your overall financial and estate plans. Charitable Gift Annuity

A charitable gift annuity is a simple contract through which a donor and designated beneficiary (if desired) are provided with a stream of fixed payments for life in exchange for a charitable gift to Pleasant View.

The donor transfers cash or securities to Pleasant View. Pleasant View pays the donor or one other beneficiary a fixed income for life. The remaining balance passes to Pleasant View when the contract ends at the death of the last beneficiary.

To participate in Charitable Gift Annuities offered by Pleasant View, beneficiaries must be at least age 60 at the time of the gift and donate a minimum of \$10,000. Payout to the donor is

calculated based on the age of the donor and any other beneficiary using guidelines set by American Council for Gift Annuities (http://www.acga-web.org).

A charitable gift annuity is an excellent tool for consideration when a donor wants to support the mission of Pleasant View and wishes to receive guaranteed fixed income for life while receiving current and future tax benefits.
